RIGHT TO INFORMATION ACT, 2005 OFFICE OF THE COMMISSIONER OF POLICE, BANGALORE CITY MANUAL U/S 4(1) (b) of RTI Act, 2005

1) The particulars of its organization, function, duties

ORGANISATION:

Bangalore City is the first City to have a Commissionerate in the State of Karnataka. The Commissionerate came to be established in the year 1963 and started functioning with effect from 4-7-1963. The 1st Commissioner of Police was of the rank of Dy. Inspector General of Police. Now, the Commissioner of Police is in the rank of Addl. Director General of Police. The Commissioner of Police is the head of Bangalore City Police Unit. The entire administration is vested on him. Commissioner of Police is also vested with the power to act as District Magistrate, Bangalore Urban District.

With a view to ensure and smooth functioning of Police force in Bangalore City, the City is divided into 7 Divisions and Traffic Divisions. Each Division is headed by an Officer of the rank of SP(DCP) supervised by Addl. Commissioner of Police, Law and Order, and Addl. Commissioner of Police, Traffic who are of the rank of Inspector General of Police who in turn apprise to Commissioner of Police. Each Division has a complement of Police Stations under the charge of an Officer in the rank of Police Inspector and other junior level officers, such as., PSI, ASIs, and PC. ACP are the supervisory officer of the respective Sub-Division who supervises the work of Police Station and reports to the DCPs.

In addition, the Bangalore City Police also consists of the following Divisions headed by DCP and supervised by the Addl.Cps and Jt.CPs

The City Police has been providing excellent services to the million of people with well established community participation in all its activities including prevention and detection of Crimes, Traffic awareness, providing security to the life and property of its citizens by working round the clock under the guidance and supervision of Commissioner of Police

1) Addl.Commissioner of Police, Administration is a link in the chain of responsibility between Commissioner of Police and DCPs of the Divisions. He assists the Commissioner of Police in day-to-day work. He is also advisor to the Commissioner of Police in the matter of transfers, postings, leave, reward, punishment, appeal, pay and allowances and sanction of pension to the entire officers and men working under COP Unit, assisted by the Dy.Commissioner of Police, Administration, Dy.Commissioner of Police, PRO., Administrative Officer, Asst.Commissioner of Police, Control Room and Asst.Commissioner of Police , DEs.

2. Addl.Commissioner of Police, Law and Order is the incharge of maintaining Law and Order, providing securities to visiting dignitaries and collection of advance intelligence about the activities of various sections such as Political, communal, students, labours etc. He is assisted by 9 Dy.Commissioners of Police, viz., East, West, North, South, Central, South East, North East Divisions, Intelligence and VVIP Security and other Sub-Divisional Asst.Commissioners of Police.

3. Addl. Commissioner of Police, Traffic is the incharge of Traffic Wing in Bangalore City and all round development of Traffic infrastructures, Planning and Scientific modernization improvements, Road Safety and Enforcement of Traffic Rules and regulations in Bangalore City. He is assisted by 2 Dy. Commissioner of Police, Traffic East and Traffic West Divisions and 9 Asst. Commissioners of Police of Traffic Sub-Divisions.

4. Addl. Commissioner of Police, City Armed Reserve is incharge of 3 Armed Forces Units stationed in Bangalore City assisted by 3 Dy. Commissioners of Police, C.A.R. Headquarters, C.A.R South and C.A.R North. They assist the Local Police in maintaining law and order during emergency and as and when men required.

5. Jt. Commissioner of Police, Crime: He takes steps for prevention of Crimes, dealing with any unusual outbreak of crimes, scrutiny over the course of the investigation of the cases. And supervision over the investigation over the complicated and sensational cases, assisted by the Dy. Commissioner of Police, Crime and 5 Asst. Commissioners of Police, CCB., and 1 Asst. Commissioner of Police, CCRB.

OBJECTIVES:

The objectives of the Police Department are as follows:-

- a) It is a Law enforcing authority
- b) Provides justice to one and all without any discrimination.
- c) Protects lives and liberties of the people from criminals and anti-social elements, brings about the confidence, faith and quality of life
- d) It is guardian of ensuing internal security and peace to its citizens
- e) It anticipates and prevents major internal calamities and protect the life and property of its citizens.
- f) Earn the good will, support and active assistance of the community.
- g) Co-ordinate with other wings of the criminal justice system
- h) Provides equal treatment to all regardless of caste , religion, social and economic status or political affiliations.
- i) Promote human rights and show special consideration to women, children, senior citizens and weaker sections.
- j) Strive to improve professional knowledge, skills and attitudes and adopt modern methods in police work.
- k) Foster professional values in policing with special emphasis on integrity, impartiality and efficiency.

SPECIAL UNITS IN BANGALORE CITY UNDER COMMISSION
POLICE

There are Special Units in Bangalore City to perform specialised Police functions and to assist jurisdictional Police to perform their duties effectively. Such as :-

1. Special Branch: This Unit is headed by DCP Intelligence. Assisted by 3 ACPs. Under this unit, the information about the activities of Political, social, labour, student, communal, anti-social elements and terrorists are closely monitored. This Unit will alert the jurisdictional Police about the anticipated problems and help them to prevent such problems. This unit is the invisible nervous system of the Police Department. Further, Special Branch also deals with the foreigners registration, passport and job verifications and other matter related to Foreigners Registration Office.

2. VVIP Security: This Unit is headed by the Dy. Commissioner of Police, assisted by 3 ACPs. This Section provides security to the visiting dignitaries visit within and abroad, take all preventive measures at the function places attended by them/ Escorts/Protect them right from their arrival till departure.

Ex-PM Security: Provides security to all the family members of Ex-PM Shri H D Devegowda.

3. C C B: This Unit is headed by DCP Crime assisted by 5 ACPs of CCB exclusively deals with the all sensational cases entrusted to them. There are different squads such as Homicide & burglary, organized crime, Fraud Squad, Special enquiries, Women & Narcotics. In addition to this, the CCB officers will also take up the investigations from the jurisdictional Police which involves inter-state investigation..

4. C C R B: Is headed by ACP under DCP Crime wherein all records pertains to Crimes and criminals are maintained. State-wise, Class-wise offenders/criminals are maintained. Service of summons/warrants to witness/accused received by the Commissioner of Police are executed as per the court order.

Photograph's Section: The photographic Section of COP Unit performs under the supervision of ACP CCRB wherein the photographs of all criminals and scene of occurrence of heinous cases other various cases and video /photo coverage of all COP Unit functions.

5. Control Room: Is headed by ACP under DCP Admn . In Control Room all communication systems are monitored and also co-ordinates with the jurisdictional police in discharging day-today work.

Police Training:

The short term basic training to the Traffic, Civil and Armed Police in Bangalore City are being given at TTI , PDMS., Yelahanka & C A R Headquarters.

Planning & Modernisation: Traffic & Road Safety: Is headed by Asst.Commissioner Police, Traffic Planning under the supervision of Addl.CP Traffic & Security, Bangalore City. In this Section all the matters related to traffic problems are dealt with. Further the improvements such as introduction of scientific infrastructure, modernization, installation of traffic signals, monitoring of surveillance cameras, road painting, erecting of barricades, installation of centre medians are being done. And also various issues relating to the de-conjunctions of traffic is also under survey. The consolidated proposals for traffic improvements are being submitted to Government through D G & IG P., Karnataka State for sanction.

THE POWERS & DUTIES OF OFFICERS

The duties and responsibilities are

- (1) promote and preserve public order;
- (2) investigate crimes and apprehend the offenders and participate in subsequent legal proceedings connected therewith;
- (3) identify problems and situations that are likely to result in the commission of crime;
- (4) reduce the opportunities for the commission of crimes through preventive patrol and other appropriate police measures;
- (5) aid and co-operate with other concerned agencies in implementing other appropriate measures for prevention of crimes;
- (6) aid individuals who are in danger of physical harm;
- (7) create and maintain a feeling of security in the community;
- (8) facilitate orderly movement of people and vehicles;
- (9) counsel and resolve conflicts and promote amity;
- (10) provide other appropriate services and afford relief to people in distress situations;
- (11) collect intelligence relating to matters affecting public peace and crimes in general including social and economic offences, national integration and security;
- (12) perform such other duties as may be enjoined on them by law.
- (13) The police officers have been given powers under the code of Criminal Procedure, 1973 (Act No.II of 1974), the Karnataka Police Act, 1963 (Karnataka Act No.4 of 1964), and several special acts notified by the Government of India and the Government of Karnataka in regard to these duties.

III. Procedures followed in the decision making process including channels of supervision and accountability

Commissioner of Police is assisted by 4 Addl Commissioners of Police of the rank of IGPs and 1 Jt. Commissioner of Police of the rank of DIG, 14 Dy. Commissioners of Police, 46 Asst. Commissioners of Police and many No. of junior subordinate officers to assist Commissioner of Police for the smooth functioning of the Bangalore City Police.

IV. The norms set by it for the discharge of its functions:

The administration of the Police throughout a district or part thereof, shall be fully vested in the Superintendent of Police/Commissioner of Police. His work is of varied nature.

- a) to keep the district peaceful and the public satisfied with the security afforded to persons and property;
 - b) to keep the force under control, in good discipline, well-trained, efficient and contented;
 - c) to maintain cordial relations with the magistracy and other officials and non-officials;
 - d) to ensure that the transport, arms and ammunition, stores and buildings belonging to the department are maintained in good condition;
 - e) to promote good police-public relations;
 - f) to organize good intelligence arrangements.
 - g) to acquire full and detailed knowledge of the district and its current problems from the Police point of view;
 - h) to participate, to the extent possible and permissible, in welfare activities sponsored by official and non-official agencies;
 - i) to gain the confidence and loyalty of sub-ordinates by personal integrity, impartiality, devotion to duty, and a high sense of justice;
 - j) to ensure by consistent supervision that the prevention, investigation and detection of crime in his district are properly and efficiently dealt with by the force under his command;
 - k) to get to know all officers and men serving under him, redress their grievances, if any, encourage those who are promising and effectively deal with those who are guilty of misconduct or remiss in the discharge of duty;
 - l) to ensure the honesty and integrity of his subordinate officers;
 - m) to study crimes and criminals in his district as a whole; and
 - n) to pay surprise visits to the police stations at irregular intervals and check up whether officers and men are alert.
- (v) the rules, regulations, instructions, manuals and records, held by it or under its control or used by its employees for discharging its functions;

(vi) a statement of the categories of documents that are held by it or under its control

Following records are held by the Department :

- 1) Records of cases registered in the Police stations.
- 2) Routine Office records.

(vii) the particulars of any arrangement that exists for consultation with, or representation by, the members of the public in relation to the formulation of its policy or administration thereof;

Committees such as peace committee, neighbourhood watch committee, involving members of the public have been constituted in the Police Station limits to render in assisting the jurisdictional Police for maintaining security of property, and peace in their jurisdictions.

(viii) a statement of the boards, councils, committees and other bodies consisting of two or more persons constituted as its part or for the purpose of its advise, and as to whether meetings of those boards, councils, committees and other bodies are open to the public, or the minutes of such meetings are accessible for public:

The decisions and advise since taken by the Departmental Officers no public involvement is entertained. However at the time of communal clashes and other sensitive situations members of the public were invited for holding peace committee for bringing normalcy in the affected areas.
